However, after much discussion, council concluded that clarification was needed regarding differentiation of all temporary grades ("DE", "PR", and "I"). §I.A.5: Council proposed a new grade – "DW = Grade assigned when the student drops a graduate course after the census day (12th day of class)." §I.A.5: Grade FA/PA Dr. Brower explained that the grade of FA/PA was added in order for PLFSOM to align with 	 Dr. Ogden called for a motion to approve all suggested changes to the draft of HSCEP OP 77.19 (Exhibit C) – with the exception of temporary grades "DE", "PR", and "I" – from the voting members of the council present.
