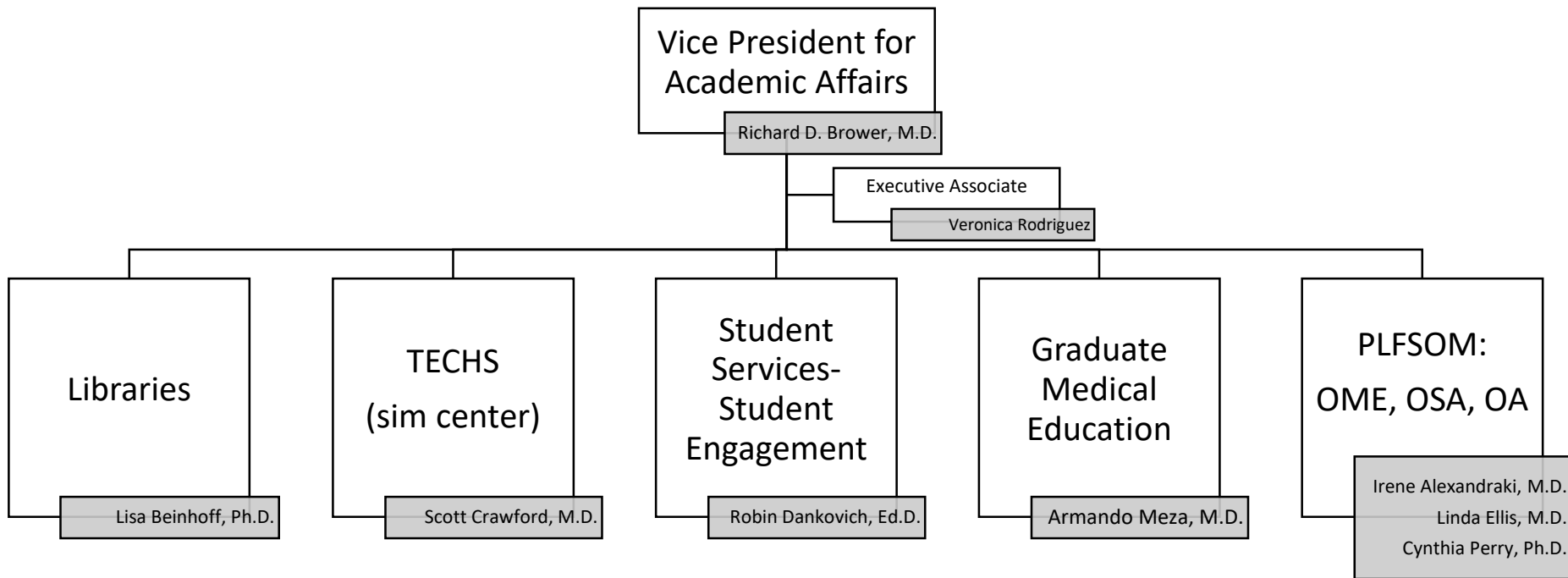

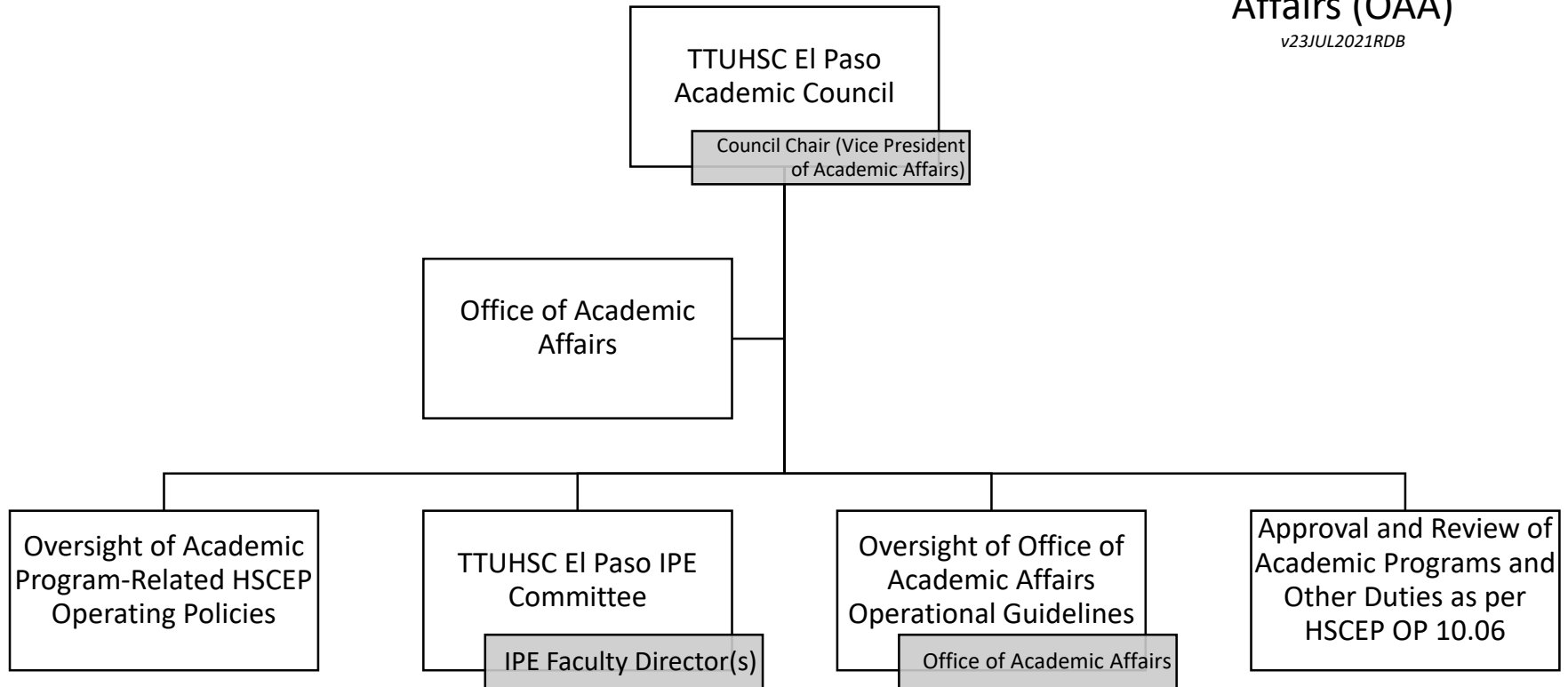
Operational Reporting Lines Involving Units
