After receiving approval from the Texas Tech University System Board of Regents, Texas Tech University Health Sciences Center El Paso submitted a request to exceed the Annual FTE Cap to the Legislative Budget Board and the Governor's Office of Budget, Planning and Policy. The request to exceed was from 545.50 FTE's to 641.50 FTE's. The FY 2017 four quarter average FTE's for the institution is 614.6 which is below the requested level.
