SON OP 60.025 Essential Eligibility Requirements/Compliance with American

**Disabilities Act** 

**PURPOSE** To provide guidance to students and faculty about the necessary activities that a

nursing student must be able to perform. This policy is complimentary to HSCEP OP

<u>77.14</u>.

**REVIEW** The OP shall be reviewed by the Associate Dean of each even numbered year with

recommendation for revision forwarded to the Dean or his/her designee of the

School of Nursing for final approval.

## POLICY/PROCEDURE

## **Guidelines for Students - American Disabilities Act**

ADA Guidelines apply to all qualified disabled persons. A qualified disabled person is a person with a disability who, with or without reasonable modifications to rules, policies, or practices, the removal of architectural, communication, or transportation barriers, or the provision of auxiliary aides and services, meets the essential eligibility requirements for the receipt of services or the participation in programs or activities provided by a public entity **and** who can perform the "**essential functions**" of the position.

The following essential eligibility requirements for participation in the School of Nursing and examples of necessary activities (NOT all inclusive) should be used to assist each applicant/student in determining whether accommodations or modifications are necessary.

Ability to administer cardio-pulmonary procedures. |
| Abilities sufficient to provide safe and effective nursing care.                                                                                                   | Calibrate and use equipment; position patients/clients.                                                                                     |
| Abilities sufficient to monitor and assess health needs.                                                                                                           | Hears monitor alarm, emergency signals, auscultatory sounds and/or cries for help.                                                          |
| Abilities sufficient for observation and assessment necessary in nursing care.                                                                                     | Ability to observe patient/client responses                                                                                                 |
| Abilities sufficient for physical assessment                                                                                                                       | Perform palpation, functions of physical examination and/or those related to therapeutic interventions (e.g., insertion of a catheter).     |
